Singapore – 30 January 2012 – State Street Global Advisors Singapore Limited, manager of the SPDR® Straits Times Index ETF (the “Fund”), today announced the Fund’s dividend distribution of S\$0.055 per unit. This dividend distribution is made out of Singapore tax exempt (one tier) dividends. The SPDR Straits Times Index ETF is an exchange-traded fund listed on the Singapore Exchange Securities Trading Limited.

The Ex. dividend date is 1 February 2012 and the record date is 3 February 2012. The distribution will be payable on 14 February 2012.

Distributions to investors in respect of units registered in their names will be paid directly into their bank accounts or by cheque and sent by post to the investors’ addresses registered with The Central Depository (Pte) Ltd.

The Fund is included for investment under the CPF Investment Scheme – Ordinary Account.
